CORRIGENDUM TO (A) THE COMPANY'S ANNOUNCEMENT DATED 9 FEBRUARY 2021; (B) THE CIRCULAR TO SHAREHOLDERS DATED 9 FEBRUARY 2021; AND (C) THE ANNUAL REPORT OF THE COMPANY DATED 10 FEBRUARY 2021

The board of directors (the "Board" or "Directors") of LifeBrandz Ltd. (the "Company", and together with its subsidiaries, the "Group") refers to the announcement dated 3 March 2021 in relation to the disclosure of change in interest of Mr. Saito Hiroyuki ("Mr. Saito"), Executive Chairman and Chief Executive Officer of the Company.

The Board was informed on 3 March 2021 that Bounty Blue Capital Ltd had on 29 January 2021 sold shares of the Company ("**Shares**") in the open market. Consequently, the Board wishes to inform the Shareholders that the information in respect of the shareholdings of Mr. Saito, Bounty Blue Capital Ltd, Rockwills Trustee Ltd and Blue Bay Trust contained in the following documents are incorrect:

- (A) the Company's announcement dated 9 February 2021 ("Announcement") in respect of, amongst others, the proposed subscriptions of up to 306,000,000 new Shares at an issue price of S\$0.005 per Share, by Franz Elioe Narcis, Irene Ng Ai Chen, Tan Lay Keim, Yu Wei Ting, Patrick John Lim Kuoh Weih, Tan Ou Seng, Ang Peng Khoon, Mohaamad Shamin Bin Mohaamad Sahafi, and Grace How Pei Yen (the "Proposed Subscriptions");
- (B) the circular to shareholders dated 9 February 2021 (the "Circular") in respect of, amongst others, the Proposed Subscriptions; and
- (C) the Annual Report of the Company dated 10 February 2021 ("Annual Report").

Bounty Blue Capital Ltd is wholly owned by Rockwills Trustee Ltd, being the trustee of Blue Bay Trust. The beneficiary and settlor of Blue Bay Trust is Mr. Saito.

Accordingly, the Board wishes to set out the correct information below (corrections in strikethrough and <u>underlined</u> for ease of reference).

Unless otherwise defined, all capitalised terms used herein shall bear the same meanings ascribed to them in the Announcement, Circular and Annual Report respectively.
